POSITION SUMMARY

Under the supervision of a Contact Tracking Supervisor, performs contact tracing for COVID-19 cases identified through the Columbia University SARS-CoV-2 testing program. The position is a part time position, with flexible and varying hours each week.

MAJOR ACCOUNTABILITIES

Using a culturally respectful approach that builds trust and facilitates the free sharing of information, the Contact Tracer follows all scripts, policies and procedures provided through training and complies with appropriate management of confidential information related to case interviews and contacts. Specific responsibilities include:

- Reaches out to persons diagnosed with COVID-19 and contacts through telephone contact and in person meetings.
- Conducts assessments with cases and contacts and refers all to appropriate information and services.
- Conducts COVID-19 case interviews and contact tracing using a trauma-informed, culturally respectful approach that builds trust and facilitates the free sharing of information.
- Protects and maintains confidentiality and privacy of case interviews and contacts through adherence to appropriate protocols and standard operating procedures.
- Follows approved scripts and protocols, provides cases and contacts with accurate information about COVID-19 prevention and control.
- Assesses cases and contacts' service needs; provides education and risk reduction information.
- Identifies barriers to engagement efforts and appropriately escalates issues to Contact Tracing Supervisor.
- Collects and records information obtained from the case interviews and contact gathering into the data system in accordance with established policies and procedures.
- Participates in meetings and case reviews to improve case investigation outcomes.
- Communicates and coordinates with contact tracers from New York City or New York State.
- Performs related work as assigned.
