Working under the guidance and direction of the Technical Director based in Bujumbura for the RISE project in Burundi, the Laboratory and Pharmacy lead will oversee the implementation of HIV-related laboratory activities including HIV testing, Early Infant Diagnosis (EID), VL testing, other HIV-related core laboratory testing services, comprehensive specimen referral and pharmacy activities of the RISE-Burundi project. - Provide guidance and supervision for the supply chain management for drugs and consumables for RISE-supported districts
- Review the development and implementation of LQMS, including QA/QC procedures at all supported and linked laboratories, and participate in the implementation of the accreditation preparedness (SLIPTA) program and other CQI initiatives
- Provides technical support to produce PT and implementation of External Quality Assessment (EQA) for core HIV-related laboratory testing services at all ICAP support health facilities.
- Facilitate and support the revision, distribution, and proper utilization of SOPs, request forms, registers, inventory management tools, and different provider support tools.
- Establish efficient and effective sample transportation systems for TB, EID, VL, etc. as well as the return of results
- Ensure laboratory specimen and pharmacy data are correctly captured and assist with routine laboratory and pharmacy data analysis.
- Assist with the interpretation of laboratory and pharmacy results from the RISE project and provide feedback on ways to improve/streamline lab procedures and systems.
- Assist the RISE team to develop strategies to ensure timely reporting of results back to the facility and clients
